The sublease contract is terminated without giving notice. The possibilty of a renewal is - unless both parties have agreed otherwise - excluded. The landlord relies on being able to reclaim the sublet housing space after the sublease contract has expired.

### V. Liability, rights and obligations of the subtenant

- b. The subtenant promises to take care of housing space and furniture and to hand over everything in the identical condition in which the room and apartment was before the change of occupants (incl. final cleaning).
- c. The house rules must be, abided by and instructions from the owner, as well as from the janitor must be followed.
- d. If the subtenant is absent for a longer period of time, he/she must ensure that the apartment is accessible by giving a key to a trusted third party. This third party must be known to the owner respectively administration (and ideally to the janitor).

#### Keys

2 Keys (1 for the main door of the house and 1 for the apartment) will be handed out on the hand-over of the room. The subtenant is not allowed to make duplicate keys or hide or "safeguard" them. If a key or several keys are lost, then the landlord is entitled to change the locks in question and charge the subtenant for the new locks and keys.

#### VII. Cleaning

The basic rule is that the apartment is given back in the same state of cleanliness in which it was received.

### a) For the corridor of the \_\_\_\_ floor and shared bath/toilet-room

Every time the landlord's name is inscribed in the calendar (placed in the floor or/and in the bathroom) for cleaning up the corridor of the \_\_\_\_ floor or/and toilet room or the shower within the subrental period of three months, the subtenant has to do it in place of the landlord as the rules of the floor demand it. The landlord will advise the subtentant in all cleaning rules.

**Optional:** That includes sweeping/vacuum-cleaning and wiping the floor, scrubbing every basin and toilet or shower in the room to be cleaned. The cleaning of the toiletroom includes also the cleaning of the 3rd floor, washing the towel and and hanging up a new towel, aswell as making sure, that there is enough toilet paper (see the cleaning plan in the toiletroom) and emtpy the trash. In the shower room the footmats must be machine-washed.

#### b) For shared rooms in a apartment-sharing community

As the agreement between the residents of the apartment says, the subtenant has to clean the shared parts of the apartment (the kitchen, the corridor and the steps to the subtentant's room) every \_\_\_\_ weeks. That includes sweeping/vacuum-cleaning the floor and wiping it after it and wiping all surfaces in the kitchen.

## VIII. Main tenancy agreement and binding
